#### Launch of EU research project results: Life Cycle of a Hate Crime

Jennifer Schweppe, Dr Amanda Haynes and Prof Mark Walters launched the *Life Cycle of a Hate Crime* comparative report at the European Parliament in Brussels on April 26<sup>th</sup>, coordinated by the Irish Council for Civil Liberties. The report presents, in detail, the findings of in-depth primary and secondary research conducted over two years tracing the investigation, prosecution and sentencing processes for hate crime in five jurisdictions within the EU – the Czech Republic, England and Wales, Ireland, Latvia, and Sweden. Detailed recommendations for reform at the EU-level are outlined in the report.
