We are excited to announce the third biennial conference of the International Network for Hate Studies themed “International Hate Studies: Contexts and Consequences of Hate”. Global events have made our work more important than ever, as we have entered what many scholars, media pundits, politicians and activists/those working to support victims are calling and era of hate. The rhetoric surrounding Brexit, Donald Trump’s election, and the political ascendancy of white nationalist parties throughout Europe have emboldened and energized white supremacist ideologies, identities, movements and practices around the world. This resurgent white supremacy is real and violent: in the weeks following both the Brexit vote and Trump’s win, hate crimes surged to a level not seen since 9/11’s aftermath. We encourage participants to consider the historical antecedents and contemporary contours and impacts of this “era of hate” as it is manifest in hate crime, right-wing extremism, online hate, and political discourses of hate.
