We hope you had a great start into the New Year.

This month we were asked to share with you information about an upcoming free three-day course organised at the West of Scotland Regional Equality Council, which is a third party reporting centre, as well as information about the second round of the six-week Facing Facts Online Course on monitoring hate crime.

Free three-day course:

'Challenging Discrimination in Mainstream Media' is a 3 day course over 3 consecutive weeks (six hours total). This course will provide an accessible and jargonfree theoretical and legal exploration of the negative impact of 'everyday discriminatory' images and messages in mainstream media.

The objective is to inform and empower participants through a series of presentations and workshops. Participants will develop media literacy skills and enhance their ability to think critically and imagine new and original ways to challenge 'everyday discrimination' ('subtle' forms of hate speech). Participants who complete the course will receive a certificate of achievement.

The course is suitable for practitioners and students working in the areas of equality and discrimination generally. The training and workshops will be presented by Karla Pérez Portilla and Monique Campbell.
