Come Forward: Empowering and Supporting Victims of Anti-LGBT Hate Crimes

The *Come Forward: Empowering and Supporting Victims of Anti-LGBT Hate Crimes* project has just launched their [new website](#). *Come Forward* is the new ground-breaking action led by the University of Brescia (Italy) and NGO Lambda Warsaw (Poland) and implemented by a consortium of NGOs, universities and public institutions from 10 European countries. The project aims at fighting underreporting of anti-LGBT hate crime by increasing the number of dedicated reporting centres, improving the access to specialized victim support, sharing good practices, strengthening cross-border and multi-agency partnerships and raising awareness and empowering victim.
