Preventing hate crime: Funding for community projects – Deadline 7th December 2018

The aim of the fund is to work with affected communities to fund the development of projects that: prevent hate crime; respond to hate crime in our communities; increase the reporting of hate crime; improve support for the victims of hate crime; build our understanding of hate crime. The Home Office (UK) is seeking to fund projects up to £75,000. Projects are expected to finish delivery by March 2020, with all invoices submitted by 31 March 2020.
