Invitation to participate: National survey of restorative justice providers

RAND Europe has been commissioned by the Home Office to carry out a mapping exercise of restorative justice (RJ) providers in England and Wales, and to understand to what extent (if any) and how they deal with hate crime-related cases. As part of this study, all RJ providers in England and Wales are invited to participate in a short online survey about the RJ services they provide, the types of offences covered and groups supported by their RJ services.

This survey will be used by the Home Office to better understand the provision of RJ services and to consider the value of RJ in tackling hate crime, as well as enabling the development of pilots to test such approaches.
